To be honest, I haven't read it. Past experience tells me that these statements of intent are rarely carried through due to financial constraints. I am sure someone has spent a lot of time 'Cutting and. Pasting' statements from other worthy documents. We all know little will happen as a consequence.

There are a lot of jargon words like stakeholders. Who is a stakeholder? If they are residents of the county call them residents. What is a stakeholder driven approach?

All seemed very ideallic and not particularly realistic

The document is too long.

Who is it aimed at?

Could it be broken down into chunks that are usable by different groups,

e.g. Housing developers, Farmers, Conservation groups, Homeowners, Road users, Horse riders, Council workers, Business owners.

How would a member of the public know whether the information was accurate or what was provided was not presented in a way that steered the reader in a particular direction? While an 81 page LNRS document is probably necessary for stakeholders is it not a case of OTT for members of the public?

I have absolutely no idea how me as a resident would use this information to help nature recover.

it is very complex and not so approachable for ley people

Having the map and documentation is certainly important. I am slightly concerned about how decision useful they are for non-experts. GIS expertise is required to use the map, and using the documentation requires some level of expertise across nature and how it intersects with the reader's discipline

It was a long read and the map was difficult to use. I live in Rushcliffe and if there was a section dedicated to each council I would have found it more interesting and helpful to concerntrate on the area where I live

LNRS preparation process was the wrong way round, local input was requested last year but this has now been somewhat swamped by a generic landscape approach, somehow the local knowledge on sites needs to be recaptured, either now or in a full review in 3 years time, not 10.

I noted some info i know to be accurate. The usable information was only allysed to and not directly pointed to. Maybe a hyperlink would help here.

The map is not clear or easy to use and it doesn't explain how to use it. Is this document an introduction to this or a tool? There are a lot of caveats which worry me as I can't see how its going to be enforced.

Its far too complicated and you will be talking to people who are not necessarily tech savy.

Does this information actually help everybody to understand what has to be done? I think not.

By including community groups like the hucknall wildlife group and the whyburn farm campaign in you consultation and advertising this in areas where people are advocating a change in policy your councillors disagree with

There are few mapped measures in urban areas, so concerned that 'strategic multiplier' for BNG funds at priority sites deprioritises nature in urban areas, increasing disconnect with people.

Climate regulation only covers carbon sequestration. Need to include shading/cooling, flood alleviation.

It doesn't tell me as an individual anything to do.

The sections of the LNRS could be used in an interactive way with the map.

E.g. Find an area that the user wishes to develop, protect or help in some way - click on the map and be presented with the issues and considerations affecting that area. Then given links to relevant sections of the LNRS.

Reiterating: A member of the general public would likely not know whether the information was accurate or biased? An 81 page LNRS document is not a suitable document for consulting with members of the general public or is that the objective?

It feels again as though me as a resident cannot help nature recover. There is a clause there for developers. In my experience developers do very very little to help nature. They are much about profit and if they stick a tree in they think that is it.

not entirely clear on the linkage of how it will drive change

The strategy is informative about the state of nature and priority areas, but it might be hard for a non-expert to use it to make good decisions

I want to help nature recovery in my area of Rushcliffe and not really interested in the other areas of Notts

More on how LNRS works in practice. Clarify that APIBs (not just ACBs) are eligible for BNG funding via LNRS to improve/extend/manage/monitor? Clarify that nature recovery activity can start now e.g. how to bank BNG credits. Need info on priority areas where owner is already aware/willing.

Section 3) Description of the strategy area

(Is the information in this section understandable, accurate, useable?)

If you have answered "not very" or "not at all", how could we make it better?

Clear and detailed, with links to connect with initiatives in place that are already doing some of the work. This helps build a picture of the social landscape of activities that contribute to the goal, and these links also show where money should be being spent.

As above

How do I know the information is accurate?

It suggests that all the habitat creating activities done by farmers since 1980 is to no avail. Species decline is frequently quoted but nothing about species that have increased such as hares.

We have to stop destroying my planet in everything we do and this strategy is not enough!

By listening to communities you are deliberately ignoring due to your development policies

Drawing lines and areas on a map without visiting or consulting the landowner (who undertands the land best) is never a great outcome, key stakeholder involvement is key

Table 1 misses 2/3 irreplaceable habitats Ancient Woodland & Ancient & Veteran Trees.

Welcome inclusion of scrub

Lowland Calcareous grassland description misses Potwell Dyke Grassland LWS, rare in East Notts. It is Calcareous Lowland Fen w/ 300+ plant species. Correct Map to show as calcareous.

This is too repetitive.

It doesn't tell me anything about nature recovery on page 14. There is a typo on page 17, geoogy, instead of geology

INFORMATION IS INACCURATE ON OWNERSHIP/ NAMING - SEE COMMENTS

Please refer to accompanying cover letter.

It just tells me the area it does not do anything to make it better!

The document is very detailed and academic it would be more useful if tailored to the type of person or group that is trying to use the LNRS.

The types of habitat would be better presented on an interactive map - SSI areas highlighted, Nature Reserves highlighted, Irreplaceable habitats highlight Rinse and repeat

Residents can't influence flooding is huge in Tollerton. The housing development removes woodlands and watercourses across Nottm City Airfield which is rife with wildlife some protected. This has not fed into the local plan and the developers plans do not protect the wildlife they obliterate it.

some of the mapping has missed out key areas of opportunity to the south of Newark and conversely appears to have mapped areas of urban expansion

The strategy is informative about the state of nature and priority areas, but it might be hard for a non-expert to use it to make good decisions

I can do my bit, but this has to be council driven also. Planning can change this! Each application has to be vetted on protecting the land and building to bring nature in.

Very clear and detailed info, accurate descriptions of the issues, great links, but again extremely difficult to navigate with mobile phone. Maybe colour coded icons would help distinguish what is a resource aimed at individual participation from those aimed at guiding business decisions.

If you expect the 'man in the street' to trawl through this to the end you are mistaken

How can I tell if the information is accurate?

How many people are really going to read all this page after page of densely-written screed and then take it all in?

Agricultural use of chemicals and fertiliser has declined over the last 10 years.

Why do developers remove boundary hedges and replace them with wooden fences?

A good deal of work has been done under 'bee friendly Nottingham' but this is not mentioned. Also I think disused allotments, which are unattractive for growing or inaccessible for development have significant potential

Again, full of acronyms

Capacity' section. Much biodiversity loss is due to lack of capacity & funding for monitoring & enforcement of existing measures. Add this pressure & allow BNG funding to be used for monitoring & enforcement.

Invasive species specify Himalayan Balsam. (Here & as specific watercourse measure).

Is this to read the whole of the section called pressures and opportunities or just page 41? This survey is not very clear at all.

It feels like you would need a degree in Environmental studies to make use of this part of the document. If that is what is intended, as it is to be used by professional architects, lawyers and developers etc. then ok... but it is too complicated for general use.

Rinse and repeat

As a resident I can do a thing about losing Nottm City Airfield's direct loss of habitats, recreational space used by the community for 75+ years. Woodlands and grasslands will change. Loss of greenspace. Along with wider issues when the developers release contamination into the two brooks.

This section is a bit more useful for understanding what drives nature loss, but could still be hard to make decisions and actions form

More info on specific local pressures/opportunities is needed. E.g. Specific Invasive species are a problem in which specific locations? Opportunity missed to add info regarding 'willing' landowner sites. Need to better link flood actions so that BNG credits pay for works rather than councils.

You recognise the need for variety but we will have nothing but fenced off solar around our area = not good for nature, removal of mixture of habitats therefore less diversity, therefore not only little opportunity for nature to recover but an increased decline.

I feel you have been too general doing it county wide.

Plant-based options in all institutions. Bike lanes across the whole county and lanes that are cleaned and maintained as much as roads.

The opportunities for the landowner must involve some very clear outlines, the also needs to be some honesty over the issues this will also present

No mention of increasing hedgrows in urban gardens. Instead 'wherever possible' install hedghog highways in residential fencing. There should be incentives and campaigns to being back the garden hedge - especially in front gardens where they shelter wildlife from the road.

There should be more emphasis on urban creep, extensions, minor development etc and how that impacts habitat but also cumulatively increases surface water run-off (which then in turn has impacts on our rivers, water quality and increased flooding).

GNR, One Earth Solar!! You can not avoid this huge developments. You would not ignore the creation of a new town the size of Guernsey and yet you have not mentioned the combined effect of these.

Broadly agree with large scope of tree work and water work, but concerned about feasibility, and how costs may affect the willingness of partners and vol.s

I'm even getting frustrated with this questionnaire

How do I know if the information is accurate?

ACB measures are too broad to be useful (See 6) & also unambitious. Eg in Farmland SW of Southwell A/M2 & B/M4 are piecemeal actions. Habitat creation & regeneration is needed (Woodland (B/M1, B/M7, Grassland, F/M5, F/M8, Farmland G/M4, G/M5).

Can one disagree with apple pie and motherhood?

As a resident I do not see how I can use this information to help nature in my area!

again not very clear what driver will be applied

Using this requires some expertise on how nature interacts with the user's area of interest or business activities. More work would be required by the user to understand and make good decisions, it could be more easily translatable to actions

Typo on page 55 the 3rd table should be called 'Overarching Potential Measures'

Do you agree with the Priorities and Potential Measures identified in the Local Nature Recovery Strategy?

Education and enforcement of existing legislation - litter and vandalism contribute a great deal to the detriment of existing spaces let alone those to be worked upon.

Species selection is misinformed

See above, I think more needs to be done in areas that are already over developed

this question is too binary, i do not agree with all the priorites

Consultation needs to be with local landowners too whom run businesses in the area.

Other than regenerative farming, how else can the environment be enhanced while still producing affordable food?

We had a demonstration site at Gleadthorpe - DEFRA sold it!

H - Urban and Post-industrial Priorities and Potential Measures H/M5

Over-emphasis on new developments, ignoring value of existing buildings upon which 99%+ of Swifts in Nottinghamshire currently nests. Existing buildings are a critical habitat for urban birds, yet are not recognised as such.

Landowner involvement from the beginning should have been a priority, many have still never even heard of LNRS

Primary concern is that blanket approach to large areas (e.g. farmland and agricultural land SW of Southwell) has over-ridden local knowledge so action may be inappropriate. E.g. Potwell Dyke Grasslands Calcareous Lowland Fen is given Woodland B/M4 - completely inappropriate. Many other examples.

No mention of increasing hedgrows in urban gardens. Instead 'wherever possible' install hedghog highways in residential fencing. There should be incentives and campaigns to being back the garden hedge - especially in front gardens where they shelter wildlife from the road.

You need to include Grizzled Skipper in the species priorities list on page 71. Ironically you have a picture on p23 but GS needs very specific individual site management (ie it does not recover just because the overall landscape becomes healthier.). It is crucial it is a priority in its own right!

Invasive species action is covered by an 'overarching measure' (A/M3) but is also included as a woodland measure (B/M3). By that logic it should also have a specific watercourse measure (which should specifically mention Himalayan Balsam, signal crayfish etc).

Saving the habitat that Nottingham Airfield represents for skylarks and other ground nesting birds. As well as being an original meadow from the 1930s it is a unique habitat with wetland areas too and it deserves to be preserved

Please prioritise endangered and red-listed Swifts more highly in line with the Derbyshire Swifts team's advice, and as a minimum in line with the NPPG Natural Environment 2025 paragraph 017 with regard to swift bricks.

Section 6) Mapping of measures

I dont see how it will make any more difference than BAP initiatives to change teh status of threatened and declining species

An illustrated example would be excellent.

I don't understand how works. If an area is on the map, what it means in terms of development or action in that area, or who is responsible for it.

The Legend of the Mapping needs to be clear in both a written and digital resolution. The colour and pixelation of the digital copy does not clearly and legibly discern one typology from another. Some are just too similar.

I found this section unclear and worry that urban areas will be omitted

How do I know if the information is accurate?

the mapping is not overly clear, it doesn't help that it has the N&S logo written all over it

Overall a very extensive report. It is so detailed that the document could sit on the shelf unused. I think it needs to prioritise the main points needing action as a focus for going forward.

Because land out forward to the culture minister for protection and discussed with Michelle Welsh mp isn't automatically included in this study or statement.

Map is awful to use

Inconsistent Watercourse measures: River Greet & Halloughton Dumble have measures, Westhorpe Dumble & Potwell Dyke (LWS and PBIBs) have none and need at least the same measures as the above. Also add back measures proposed by EA for River Greet in first map consultation (fish passes and wetland).

maps look incredibly complicated and difficult to navigate

Interactive map is very hard to read and follow - it is very clumsy to use and not intuitive. It is not accurate around Radcliffe on Trent as it does not include the plantation on the south side of the A52 which is a brilliant rewilding project!

It is very wordy and not written in plain English.

I like the interaction map much more than I like war and peace.

again refer to earlier comments on inaccuracy of mapping to the south of Newark, it has missed some opportunities and mapped areas of development As above - some expertise is required in interpreting and making decisions on the content of the report. It may be hard for some users to understand how to best make decisions with the information provided.

Would be helpful if Map showed Local Green Space (LGS) designation and Strategic Green Infrastructure. We also want buffer strip measures, e.g. wildflower meadows, around Local Green Spaces to prevent encroachment (including agricultural run off) and allow light to reach the LGSs e.g. Spa Ponds

Whilst we are supportive of the objectives behind the LNRS and the potential measures, we consider the exact polygon shape illustrated on our Client's Site to be overly prescriptive and does not need to be implemented as such in order to achieve its stated objective. Please see representations.

Generic blanket mapping of certain measures diminishes credibility, needs more specificity based on local knowledge 'which sites are better and have a willing owner?' Clarify that APIBs (not just ACBs) are eligible for BNG funding via LNRS to improve/extend/ manage/monitor etc.

I always do what I can when I can to the best of my ability. Good to have this additional information to help steer me.

I feel not enough has been outlined, we can do better and more areas allocated / identified.

Make the titled map measures clear what they are. Also, why are large woodland areas missing?

Not the map's error that I need to learn more geography. Good link.

There is no information attached to the areas of interest apart from what they are.

See previous comments about the legend and clarity. It is also important to recognise that the non-statutory designations such as LWS which have derived from NBGRC record information which is severely out of date, This needs to be updated by survey effort and private land recognised.

I could not get the map to work at all on my android phone

I am not going to continue on a website that does not give visitors the opportunity to refuse cookies. At the very least, reputable organisations enable visitors to continue to the site by accepting only essential cookies.

not easy to read

By including public interest land that should be protected even if it's at odds with council policies

There are areas of mapping that even on my farm make no sense

Map is difficult to use. Very offputting. The whole document is 86 pages long so almost deliberately designed to put off most residents. It took me over 2 hours to read and still cannot use the map. At some point it even told me the site and map had technical issues.

Add NCC's Thorney Abbey Farm Wood to map as APIB, w/ B/M6, BM/7, BM/8.

For watercourses in (8f) extend C/M2 & C/10 along all. Add C/M1, C/M3, C/M8, C/M10.

grassland & wetland measures for NCC's 2026 Southwell Flood work at ID:U7

Add BM9 to Norwood Park's 18 Ancient &Vet Trees (X469171 Y354697)

I think the map could be made better. Its not very visually appealing, and doesn't lead to a great viewing experience. Its a bit clunky. It doesn't load or look very well on a mobile device. I'm quite surprised NCC comms team have approved it? Consider using ESRI Experience Builder instead?

Perhaps redesign the map based on the layout of the following? https://theriverstrust.org/sewage-map. The current map is very data heavy, perhaps split it into say a number of separate maps, also have filters so users can select a topic area or location to view? Consider colour blindness of user?

I think that I must be the wrong sort of person for this survey. I don't see how any of this, so far, can show me personally how to improve nature.

I feel there are some data gaps in Nottingham City in terms of mapped areas and the "ACB" locations. This is particularly obvious to me around Phoenix Park and Broxtowe Park around existing watercourses and wetlands that don't appear to have been mapped or considered.

I used postcode search to find Bestwood Country Park, this worked well. However, when I clicked the park on the map it said - no information available. I was expecting to see a summary of the the type of land, habitats and an inventory of species in the park that the LNRS is aiming to help recover.

"Do you agree with the areas identified on the Local Habitat Map? (tick one only)" Where is the "do not know" option?

No idea how to use this map. Yes I can click all the layers but what is it really showing me and how do I use it to help nature in my area? Mind you I am a resident so no one will give a toss what I say anyway!

As before missed areas of opportunities to South of newark urban fringe and mapped areas of development. there is a lot of potential and ongoing initiatives which have been missed to provide greater accessibility and development of greenspaces in this area

Key will be keeping it updated with the progress

The usability of the map could be significantly improved, at the very least with better explanation of the different layers. It would be also good if the map were searchable.

The map is clear for an expert user like me. I can see how it is useful to identify priority areas for nature and relate it to the actions recommended in the report. Without domain expertise it may be hard for users to apply the information provided to make good decisions

The proposed polygon on our Site would significantly limit the developable area of the Site, impacting its ability to meet an identified shortfall in industrial floorspace. The basis for the polygon shape remains unclear, and we question the methodology behind this. Please see representations.

I live in Bassingfield and only the water courses came up and yet we own a field which is on the Notts HER list and yet it did not show on your map.

It makes no reference at all to the multiple solar farms that are either approved or in the pipeline that will have a direct impact on local habitats.

It has made no reference at all to the Great North Road Solar Park or One Earth Solar, or all of the BESS and solar farm applications, that are set to impact on a very large part of Newark & Sherwood. These should be included on the map as a negative impact.

Add a map layer that shows where there is a landowner ready to act. Include areas where flood alleviation action is planned so that these can be partpaid by BNG credits rather than councils etc (i.e. taxpayers). Review locations at the parish/group of parish level with local people.

Alas there will always be information missing that is known to the locals. This will build up over time.

Are you aware that on a previous map someone in the Forestry Commission 'raised concerns' at the lack of tree and HEDGE planting in Laxton. Ooops

See above - the plantation area to south of the A52 off Radcliffe bypass is a brilliant new rewilded area that is not covered. There is also no mention of the walkway from Radcliffe to Cotgrave which is a brilliant nature site. The Cliff Walk in Radcliffe and Lily Ponds also need including

The detail is in code and this makes it very difficult to understand.

I live next to Lowdham Grange Prison. Opposite my house there is a communal grassland/open space areas (we call 'The Green'). This area currently has A/M2 and B/M5 going right through the middle. I believe this is wrong. These measures which may see trees planted would ruin this area for the residents as before the area to the immeadiate South of Newark has been incorrectly mapped covering some developed areas and crucially missing major opportunities to not only protect and restore the rich existing wildlife around Lowfield Lane and the middlebeck corridor but also to provide greater reconnectio

We are in the process of developing our priority sites for the next 5 years of our work. These may extend further than the areas you have identified, for example areas for BNG uplift and on 3rd party land. We wish to have a further discussion with you to assess how we can support your areas.

The Notts Wildlife Trust reserve at North Muskham, accessed from Manor House Drive, is not included. This is an important habitat within our village. Missing key areas e.g. Southwell Potwell Dyke -add watercourse measures. Add invasive species watercourse measures generally. Flood alleviation measures north of Oxton. Add general urban area actions e.g. wildlife corridors, urban green spaces, playgrounds, hedges, verges, planters, allotments.

11. If you have any additional ideas of things you could do yourself, or with others, to make the LNRS actions happen, please provide them below:

I believe we could increase by diversity and food security by including regenerative agriculture within the areas of solar farms. This is very common abroad and we do not really do it here. That are large number of farms proposed in the area so making these a whole lot better for the environment would be ideal. I am involved in sustainable hockerton who are trying to get permission for a demonstration site near hockerton. I will be very happy to discuss options and ideas.

I have good local connections, have been instrumental in creating a facebook group "Balderton Wildlife" recording local wildlife which now has 1.3K members, engaging with local centres to host art exhibitions, submitted a petition with over 2000 signatures objecting to a proposed development (which is now granted). I have a engaging personality and seem able to draw people in, generate enthusiasm and motivate people.

Happy to make my garden more nature friendly but at 86 with health issues am a little old to be very active in a group

Raise interest from charities (e.g. woodland trust) to support areas in the region.

Volunteer conservation group local to my area Balderton - I already help out when I can with litter picking - but would like to get more involved locally. To volunteer at weekends as I work, to learn new skills and meet people. Gardening club for women. Get children involved in nature and understanding nature. More planting to support pollinators - bees, use of spaces we already have to improve biodiversity. Offer training and education for children and adults

Educate on the 'right' kind of habitats to encourage in gardens.

Make the LNRS more collaborative; invite businesses, local authorities to view and consultant and start building these into their own work.

I can provide small amounts of wildflower seed from my own meadow

Involve community groups in LNR for both their own projects and also volunteering projects

Petition (shame) large housing/commercial developers - via social media into reducing profit margins and i crease contributions to local nature projects Also vastly improve design/layouts etc- eg ban hardscaping (eg fencing) and insist they use eg hedging

Limit amount of block paving, increase areas of lawns etc

Creating community orchards and community gardens. Help local schools to provide for wildlife and encourage students to take part in nature and wildlife activities. Plant wildflowers and bulbs in local green spaces and grass verges. Adding more ponds around the area (small-medium). Put up some swift boxes, bird houses, bug & bee hotels and bat boxes on trees.

I firmly believe that whilst local district councils are on board, Parish Councils are not. They are often disparate groups of people, some of whom have a green agenda and some don't resulting in little action towards green initiatives. They need help and advice from people who know and understand the issues. We run a community garden locally and are willing to help but they never ask and neither are they particularly interested in what we do save for a couple of members.

The priorities around the county provide enough for a number of small groups to assist in making it happen - local parish and town councils, volunteer groups, young people and old can all take a role.

LPA planning policy must recognise the importance and well being to people and nature. Appropriate development is the only way to realise funds to support nature recovery in particular the removal of Invasive non-native species to restore native ecology and habitats. Planners do not seem to understand the interaction of other policies ie Green Infrastructure, Environment Act 1990 etc and the use of the planning system to assist nature delivery.

Bring together community groups to help and support each other.

Clear communication channels to make it easier to take part in volunteer activities

More support for community wildlife groups / 'friends of' associations; financial and manpower. The two groups I care for both face severe issues with resources - without access to necessary machinery for maintenance, entire fields have been overrun with brambles and weeds, rather than wildflower and other more positive environments.

Bullet points of key points would be more user friendly

Funding

Make wildlife recovery and enhancement compulsory in planning applications.

Introduce automatic Tree protection orders on every mature urban tree.

Run educational campaigns in urban areas where there are still bats and hedgehogs showing the public what they can do to help.

Encourage the creation of urban ponds

Promote wild flower areas and beehives. I would like my own hive!

Improve awareness of the general publicesoecisly around issues like putting the right tree in the right place, mowing regimes and use or chemicals.

More information should be sent to individual households

I would like my land taking off the plan until we have been properly consulted and surveyed so that we can move forward together.

I would like Notts County Council to stop mowing everywhere except where it is absolutely essential for driving visibility or access.

More publicity for eating less meat.

Tax on single use plastics and non-recyclable packaging.

Grants to help groups or individuals diversify their land.

Working with parish council on wilding. Surveying footpaths and condition of local signs, stiles and bridges - to reportactively engaging with solar proposals as interested party (opposing and seeking huge mitigations)

Going vegan is the least you should do and has the greatest impact on saving my planet.

Cannot think of anything. All a bit overwhelming

Involve local businesses who are profiting from destroying wildlife and their habitats

Create relatable story telling to allow each area to incorporate LNRS targets. Although you have priority areas and species, connectivity should be highlighted and resource/materials provided to allow more community groups to establish.

You need a special meeting with the hucknall community for your strategy to mean anything at all

Nature and its 'theoretical' recovery needs to clear in terms of what we are trying to recover it to? Pre-Ice age, Post-ice age, 100 years ago? A starting point would be helpful, and then considering we are a business there needs to be some very very clear short, medium and long term benefit to the business, not just to nature. A farm can't be green if its finances are in the red

Very worried about lack of water for wildlife especially in this dry spring when we have seen many water courses dry up.

More could be done to encourage people to be more aware of this, to put water out in their back yards or gardens or water nearby trees.

A general lack of awareness and a feeling of hopelessness exists.

People may not have time or be happy to run/attend groups but would happily put out water or plant berried shrubs etc. and be rewarded by seeing the increased wildlife.

Please stop using acronyms :-)

I can ask the company I work with to support the changes I am trying to make to our land management practices.

I work in an educational establishment (Nottingham College), so I can try to get teachers on board to embed the local nature recovery strategy into their lessons. For example, I am working with a swift conservation charity to make displays for our construction students telling them about the difference built in swift bricks, bat boxes and bee bricks could make if installed in buildings

Help to make green corridors through my village if South Scarle and ANYTHING in my area and the Lowfield Lane Balderton area

Please establish a Stakeholder Group of Nottinghamshire local government Councillors who have interests in supporting the LNRS. As a Network, we could support measures for land in the public realm, amplify your engagement with other landowners in our areas (e.g. schools, churches, farmers), enable connectivity with other planning initiatives. We could also share best practice and resources with each other.

A bit on the old side

Not advertised enough to get people involved so no idea as yet how to help

I would like to see sponsorship opportunities for community groups for tree planting

I commend to your attention the Notts Wildlife Trust for its practical work in 'rewilding Notts', including the use of habitat management techniques.

Would be quite happy to be involved in work to improving the Local Habitats web map, to make it a better user/viewing experience?

I can only answer for part of Beeston because there are many areas/localities I don't really know, but there needs to be more information out there. I think pop-up displays supported by trained volunteers in empty shops and public spaces would be a good way to do it. For the record I champion Nottingham City Transports 35 bus route and publicise its 'wild side' (35 locations) and have led a few '35 wild walks'. You can find my map online at BeestonDestinations.substack.com.

We can try and do some of these things while I am at work with the children but we only see them at certain times. We are planting wildlife friendly plantswe are getting hedgehog houses making a over fly lagoonfeeding and putting water out for the birdsgrowing veg and flowerswe planning a small pond with different habitatsLots of things planned

Work in improving the online habitat map, to make it a better viewing experience for users? Consider accessibility of users who view the map eg colour blindness - include colour blindness colour palettes etc? Bear in mind that most people access the NCC website on a mobile device, the map doesn't load very well on a mobile device in my opinion. Too much data has been put on the map (no fault here!), but perhaps consider how the data is presented/laid out to make a better viewing experience?

Increase hedgrows in urban gardens. 'wherever possible' install hedghog highways in residential fencing is a very weak opportunity and should not be accepted as satisfactory - it is bare minimum. There should be incentives and campaigns to bring back the garden hedge - especially in front gardens where they shelter wildlife from the road. Show people how easy they are to maintain ot offer maintenance services.

Better use of social media platforms - to start conversations; to educate people with reliable (& sourced) correct information; to clearly & definitively debunk urban myths about nature/wildlife

Teach countryside code in schools and on signposts.

Encourage users to stay on designated pathways.

Police to stop motorbikes using woods.

options overlook activities related to built environment - eg to help bats and swifts - and those in our homes and other living/working spaces - which can help conserve water, reduce pollution etc. Clearly there are a whole load of lifestyle actions that can help nature, some with a more local impact than others.

Please add better management of Himalayan Balsam along the River Greet Southwell to the map. It needs urgent action from landowners.

Reducing use of Glyphosate by VIA EM along roads and pavements. They need to seek alternative methods of vegetation control

Reduced mowing on grass verges by farmers.

Managing healthy hedges by farmers rather and an annual flail

Education and support for gardening for wildlife

As a joint landowner, I would like to help promote nature-friendly development (highway and if possible a small housing estate incorporating Beacon Wood) to all interested parties, such as Newark & Sherwood District Council and housebuilders such as Bloor Homes, Barratt Developments, William Davis Loughborough.

Why have you used GDPR as an excuse not to reach out to farmers and landowners?

It just needs a legal framework behind it. The overall document is brilliant and a lot of work has gone into it but I sadly really struggle to see how this will protect our nature from developers as there is no legal force to it from what I can see.

Adopt an unloved green space and work with local authority to make a specific plan to help nature.

My health now excludes me from much activity but not of course from filling in questionaries.

Colwick Parish Council is committed to leading and supporting our community in enhancing the local environment and quality of life for all residents. Our new Action Plan sets out "Environment & Planning" as a key theme with the aim of "providing stewardship of the local environment and biodiversity, and ensuring development is sustainable and aligns with community interests". Our objectives within this theme include enhancing biodiversity & promoting local awareness of climate change.

i manage all the local wildlife sites on Lowfield Lane and have had no support or funding to maintain this. this area is currently not mapped and i would implore you to do so to protect this incredibly rich biodiverse area, which has the support of the local community over 1400 members on the facebook group sharing wildlife photogtraphs. It is a perfect example of a rich accessible urban fringe area used by so many that can also link with other wildlife corridors and deliver multiple benefits

We have a lot of established partnerships in the region and want to utilise these more to help action the LNRS. We want to your LNRS to develop our species recovery plans. We can share our mapped plans offline outside of this survey and welcome a two way discuss on this.

Species reintroduction - River Trent Beavers.

Pressure on central government to fund nature correctly, bring back SFI or some incentives for private landowners to mange their land for nature increase inspections to ensure it is done accurately.

Nature recovery focus groups

I'd like to see local councils stopping using weed killers to control unwanted plant growth in urban areas. Use of strimmers or other manual aids should be used and some of the money allocated to LNRS should be allocated for this purpose. Urban gardens could be a rich source of pollinators and wildlife and efforts should be made to educate people to increase biodiversity in gardens by introducing wildflower areas, using hedges rather than fencing and walls and discouraging insecticide use.

Identify locally any additional habitats or species not already recorded to help to evidence any progress towards nature recovery goals.

12. Is there anything else that you would like to tell us about the draft Local Nature Recovery Strategy?

Please do more and involve planning fully, they have to be completely engaged in this.

We have already set up our own nature reserve in Gunthorpe, now slow the traffic down on the A6097 to reduce the pollution. It's the one area that has been ignored.

We need to make sure the council on all its ground does not use pesticides. The use of glyco phosphate in particular is very harmful and should be stopped immediately by either council and all its contractors.

Please could you re-consider the remaining area of Lowfield Lane. It's a naturally beautiful lane, not manufactured, it's accessible to all and take a few moments to view some of the wildlife present there on our facebook group.

I think it is a brilliant idea and I just hope lots of people get involved

I would like to know more about specific plans and not just processes and broad principles.

The document is wordy the summary document is good - do you have an easy read version for those that might require this or available in different languages? How are you going to promote this. We need to bring the community together, educate and become actively involved In protecting nature before it's too late

The health of our rivers and the biodiversity they support is a real concern. I hope our rivers, streams and other freshwaters can be prioritised, to benefit both people and nature. Thank you for this opportunity to comment, and good luck!

I found a greengage fruit tree on the site. I don't think people are aware of it. There are lovely plum trees too. If these are kept you could make jam with the fruit to raise money. The blackberries are often picked by local people to.

Hundreds of hours of well meaning effort by hard working, knowledgeable staff, but how will it have any more impact than the current initiatives. LNRS needs to be funded directly by BNG through a straightforward tax on development (not the current ridiuclous system that is in operation) and removal of farm stewardship to obligatory requirements on landowners to deliver biodiversity. This is not a Nottinghamshire issue - it is a national scandal and after nearly 40 years of scheme after scheme and nothing working - LNRS is just the latest that will make no difference.

Introduce financial incentives to local residents/businesses to roll out green projects

In my opinion, it is too long. I would suggest that you have a page or two which precis the information provided in the full document.

Glad it's begun, wish it had more teeth, some ecocidal activities need to be handed punishments or deterrents that really work.

In order for it to be meaningful in consultation it needs to be much more 'punchy' in layout and information. To me, most people wouldn't be bothered to plough through all that information, which will then mean no feedback... is that the intention??

There are repeated caveats about how this is not a delivery plan and won't force people to comply, which is worrying. Is it a box ticking exercise? Invasive non-native species are a very significant threat to biodiversity and nature recovery. The removal of these species and replacement with native planting should be afforded the highest priority and invasive non-native species should be weighted as a significant negative score in an updated BNG Metric. Invasive non-native species should also be prioritised in all policies for removal.

We are looking at how we can remove the 'designations' since already do this work we do not wish to be forced into a position where we cannot afford to be.

The council contractors who perform the work need greater understanding about biodiversity and ecology. They continue to destroy plants and habitats with their machinery, rather than sympathetic gardening. They are key to ensure what the council says and what actually happens are consistent.

Just to reiterate how important it is to protect urban wildlife. Much of urban Gedling has only been urban for a few decades and populations of deer,

Badgers, hedgehogs are trying to survive in ever shrinking habitat. Without human intervention they risk starvation or isolation from other breeding populations. We need wildlife corridors across the city and the suburbs joining up these habitats. Council owed parks could do more to provide habitats for wildlife by rewinding parts of the parks and introducing ponds and wetlands.

Just make it simpler

It is ridiculously long and densely-worded. I doubt that most people would be bothered to read through 80 pages. Even fewer would have any chance of retaining everything in it if they survive through to the end.

its interesting that there seems plenty of money to throw at this but the successful SFI scheme that took 8 years to produce and implement at great expense, was scrapped after 2 years, and will probably take years to replace given how fast government works. This was probably the best vehicle ever created in the UK to promote improved wildlife and environmental improvements whilst also helping farmers remain solvent, it was a bargain to the taxpayer

Promoting and caring for more nature reserves and beehives

Stop the building at nottingham airport as they're loads of important wildlife that vistry would destroy if they get planning permission to build loads of new housing

We need action not words. Common sense doesn't need grand gestures and schemes.

Some very special places are being given over for building which is wrong and they need protection! Brown sites are better for building green spaces need more protection

I am looking forward to reading the whole thing...and will answer 7-10 then

The strategy seems good. I would however like to see more focus on connecting those in the city with nature. Schemes like the Nottz Garden Project are doing great things to bring nature to those in urban areas. Although this may not directly affect and improve habitat on a large scale, it will educate people to the benefits of nature and what they can do to help. This can improve attitudes and cause them to respect the green spaces they visit. Urban wildlife is also very important.

Please encourage Rushcliffe Borough and East Leake Parish Councils to stop allowing the early annual mow of Meadow Park. It always happens just as all flowers are in bloom in the summer. It should be left until autumn. They should also be ordered to stop mowing everywhere that is not essential. I tried to stop this from the inside (as a Parish Councillor) and failed to achieve through lack of support.

Just curious how little considerations is given to the devestating long term impact of 'industrialising' our north notts landscape . The entire Trent valley here and across the border in Lincolnshire is being devestated- and DeFra don't seem to be engaging positively to help / halt proposals at government level.

It must be available to all schools and businesses.

Lot to take in and not sure what impact it will have and who will.use it.

Urban and Post-industrial Priorities and Potential Measures recognises the 4 red-listed urban birds: house sparrow, starling, house martin and swift yet only recognises new developments as a potential site for universal nest bricks as breeding sites for these species. What this ignores is that the vast majority of these birds in urban environments are nesting on EXISTING buildings yet this habitat is totally ignored in the LNRS. This is a fundamental misunderstanding which can only result in decreases in the populations of these species as existing buildings are renovated and vital nests lost.

That its politically and economically motivated

I would delay its finalisation to make sure every single landowner is individually contacted. You won't get the buy in, to push this strategy through if you rush it without a proper consultation period.

The power of ordinary individuals, who may not want or have time to volunteer or attend groups, is being overlooked! I feel this is hardly touched upon and therefore neglected in the strategy which most is aimed at big organisations or local groups. Many are desperate to help but are unaware of simple

things they can donto make a big difference. Putting out water when it is dry. Watering local trees in times of drought. Gaps in fences and gates for wildlife to come and go. Planting berried shrubs and pollinators Social media ads but also simple posters on notice boards work!

Please keep me updated.

Support for local communities and volunteers to engage with local land owners and managers to collaborate on nature recovery projects.

Many do not know about it, even when working in similar area such as green social prescribing

The strategy is 82 pages, plus the appendices - this does not make it an accessible document for most of the public, and therefore by definition is not inclusive - perhaps that's the intention to limit public involvement. I could count on one had the number of times Hucknall was mentioned and the key areas surrounding our town, and on several places, we are swept under the heading of greater Nottingham. There's little mention of how the compatibility of the maintenance/creation of these areas with the Government's stated intention to build 1.5 million homes.

Are landowners/involved parties going to be expected to find training and funding themselves to make these changes? For example: farmers adopting regenerative practices? Because these are skills that need to be learned, and there are costs involved.

- Potwell Dyke Grasslands (PDG) and Brinkley Pond, both both Lowland Fen, & LWS & APIBs.
- ACB of Farm/woodland that SW of Southwell. NTU Brackenhurst is there & can support.

Urban measures should be added to ID:U7, including reduced herbicide HM3 (which the council is partially implementing) and measures associated with built environmet (HM4- 12) which are consistent with Southwell's revised Neighbourhood Plan.

Think there are also gaps in the narrative around how people engaging with nature through better access, training, wellbeing and future engagement supports not only nature recovery but sense of unique place.

Turning front gardens from grey to green - see Green Southwell campaign on website

More emphasis on EVERYONE being responsible = not just farmers, developers, councils. Private gardens area massive space potentially for wildlife.

More and better protection for trees - see Woodland Trust campaign.

For soil health have you consulted with the Soil Association for the farming section?

Species lists seem quite narrow - seems to me ALL wildlife should be a priority - bees, pollinators, butterflies, birds etc

Heathland - dog mess, litter, fires are the issues

Neonics - big issue for beet in Notts

Not really. It seems to be a very thoroughly comprehensive document

It will only be properly delivered if considerable funds are made available to do so by Government through ELM, Species Grants, EA/NE etc..

The Strategic Significance Multiplier may have unintended consequences for less BNG delivery.

I believe that there is huge potential to make Beacon Hill in the future Newark East suburb a beacon of nature conservation integrated within new housing.

****** would welcome the opportunity to engage further with the development of the Local Nature Recovery Strategy (LNRS). We would appreciate the chance to review and provide feedback on future drafts ahead of formal adoption to ensure the strategy is informed by practical development considerations.

- 1. As a dairying business, the dairy that purchases my milk already has carbon and biodiversity requirements needing to be fulfilled as a prerequisite to them purchasing my milk. My dairy business will not be able to undertake two sets of requirements (unless they can be double counted!)
- 2. Why are natural environment habitats that are already well managed and species rich being mapped into the shceme>

I searched for Squirrel in the draft priority species list.

There were only 2 references, there was no mention of the impact of SQPV on nature recovery of our Native Red Squirrels, I feel this is a big omission. Education is key to getting land owners on board and we need the public to be aware of SQPV.

It is a bit 'faceless' ! I'd like to know who is going to be accountable for it and make any of it happen. Although it is a quality document it still feels like a box ticking exercise and not something that will actually drive beneficial change in the county. A great example is that currently a large parcel of land next to Skylarks nature reserve/Holme Pierrepont country park is up for sale. If the powers that be were serious about nature recovery that land would be bought by public funds (govt/councils/rspb/wildlife trust and turned into a nature reserve but nothing is being done instead!

As I am not an expert in the subject then no. Though one point I would like to make is that new housing developments now seem to include so called balancing ponds. What part could they play in improving biodiversity in an area?

I see the LNRS should feed into the Local Plan! We have a 95 year old Nottm City Airfield in the plan! There is so much wildlife that will be wiped out. Ground nesting birds. You cannot just flatten a whole area, kill off habitats and expect the wildlife to clear off somewhere else. It is an important breading ground and wintering site for endangered birds (linnet, yellow hammer, skylark, lapwing, curlew). Also hares, deer, otters, badgers, newts. Once excavations commences contamination from 1200 buried WWII planed will end up in the watercourses as ****** **** ***********.

Once adopted we would welcome further discussion on how we can best support at a local community level. Like many other town and parish councils, we believe that local councils have a unique and positive role to play in helping principal authorities and other stakeholders reach out at grassroot level to raise awareness and stimulate activity to support the aims and objectives of the strategy, enabling local people to positive affect and enhance their environment and quality of life.

There seems little opportunity to identify areas that should have been included on the Local Habitat Map. Responsible authorities must ensure that the consultation allows for local intelligence to inform the process and so maximise opportunities for nature to recover.

I live next to Lowdham Grange Prison. Opposite my house there is a communal grassland/open space area (we call 'The Green'). I think this is owned by the prison but they have nothing to do with it. This area currently has A/M2 and B/M5 going right through the middle. I believe this is wrong and would like to see this changed. These measures which may see trees planted would ruin this area for the residents. Instead I suggest this areas is covered by measures B/M6 or H/M2 to keep this area a relatively uncut grassland and a natural hub for pollinators/insects/house martins/swallows etc.

Please listen to and acknowledge the views of the local community in designating these areas. It should provide a great opportunity to incorporate an area where the local community already cherishes and values its wildlife and greenspaces and there are multiple opportunities to take this forward with willing partners for multiple benefits

The maps could all do with major conurbations marked on them for reference.

Is there a possibility to link in with BUGLIFE beelines as these aim to create linked habitats across the whole of the UK to see if the identified 'potential habitats' in Nottinghamshire align with these and if not could we change or add in more 'potential habitats'.

Training potential surveyors not just in the usual species covered e.g. plants, birds and mammals but in invertebrates as some many of the birds and mammals rely on invertebrates.

We feel there is a lot of value in working together to bring the most value in the Nottinghamshire region, particularly:

- Social Value
- Citizen science (this is an aspiration)
- Species recovery
- -Biodiversity net gain
- -Forestry (eg commonweath)
- -Agriculture and catchment management
- -Influence on 3rd party land with established partners
- Utilising the strategy for best practice for land management of our own land in the Notts region

Important to educate people to encourage wildlife friendly gardening and discourage "neat and tidy" being the aim. Simple ideas such as hedgehog highways are essential. I also think more emphasis should be on creating wildlife corridors rather than pockets of habitat. Restoring continuous waterways is an obvious way to do this. Another way is to create rewilded areas around roads and railways. Burning moorland to make it suitable for grouse should be stopped as should the introduction of pheasants for shooting purposes. Introducing vast numbers of non-native species for sport is reckless.

I am sure that this will be a living document to a degree and will hopefully document any future projects and initiatives to evidence any nature recovery and benefits that arise as a result of the strategy.

Protect all LWS in particular Park Hall Lane LWS Mansfield Woodhouse. Mansfield District Local Plan should not be allowed to allocate over 400 houses to land that us surrounded by an LWS this would be disgraceful

This is generally a great standalone doc and map. There are some ways in which it could be clearer and more easily applicable to businesses, landowners and other stakeholders who might use it. Nature is important, but for stakeholders who have lots of different and competing priorities it is always had to see how nature can fit in, and even help improve/deliver on other priorities. There's a real opportunity here for us to optimise land use on large scales and make sure all our needs are met but we're still not quite there

We appreciate the collation of relevant documents and data and can see that a great deal of work has gone into producing this draft.

To continue my feedback for section 3. It would be great to include reference to Great Crested Newt conservation works at NTU as an example of a current initiative. GCN are listed as a species of importance and it is a great example of the measure D/M6. It's important that Local Nature Recovery is prioritised at a local level through focussed and evidence-based work. This must be a joined-up approach to ensure biodiversity is improved across the country. The Local Nature Recovery Strategies (LNRS) will have a hugely positive impact on Nottingham, Nottinghamshire and its residents, who will benefit from local nature recovery.

Whilst LNRS objectives supported in principle, clarification of the mapping methodology is necessary. Assurance is sought that habitat measures won't hinder delivery of vital industrial development on our Site, which is currently being promoted for development through the plan making process. The proposed polygon is overly prescriptive. We propose relocating these measures east, along the railway, to balance biodiversity goals with development viability, thereby allowing green infrastructure and biodiversity net gain while retaining flexibility in site design and minimising planning conflicts.

The Local Habitat Map has relied upon data, some of which is out of date. One LWS in my area has been sold by the County Council for a housing development, along with adjoining school playing fields, which are identified as an ACB. Accuracy in the map is important and its ongoing maintenance is vital, if it is to become a material consideration in the planning process.

This consultation response is supplementary to my earlier submission under the same email address.

Make your voice heard regarding the forthcoming planning application for the Tollerton / East of Gamston Development and the implications of the loss of wildlife habitat this will bring by developing nearly 500 acres of land, of which half is grade 3 farmland. This is home to hares, pheasants, rabbits, deer, mumjack, barn owls, nesting birds such as skylarks, cuckoo, reed warblers swans, ducks in the Polser Brook which forms a boundary to the development: butterflies and dragonflies, bumble and honey bees pollinating the crops and bats in the pillboxes. Not enough characters to continue.

My main point to make us about the Tollerton City Airport redevelopment. Whilst I agree that the site may not be suitable for housing development I also think flying should not be allowed as it gives a serious public health hazard from lead pollution caused by the aircraft fuel (AVGAS)

I think it's a very good plan and hope it happens. Careers associated with nature recovery and management need to be better profiled. The management of land, species etc is so important. I worry that the current government does not take green management seriously especially with their quest to sweep away ecology in planning in their pursuit of building more and more houses. I would like my grandchildren and their children to live on a sustainable planet with lots of nature helping the planet and for them to see and enjoy trees, flowers, birds, butterflies, insects, mammals etc.

Good but I feel a bit of a missed opportunity and too generic in places, not to repeat points already made but I do think this draft needs more:- local specific info (and local engagement on those local specifics)- info on landowner willingness (I do think this is key to ease of use)- joining up with future flood alleviation works to save council's money- info on how the LNRS - BNG credit process will actually work in Notts - how to bank credits etc. That should be made clear so that landowners don't just sit and wait.

Where is information related to solar and the devastating effect these are having on nature. You show an area in NSDC as ACB matching the GNR solar farm. ALL nature/life is dependant on that top 6 inches of soil, soil is matured by the sun and weathering and yet the solar panels will obscure this for 40 yrs. In addition to GNR there is One Earth Solar = way too much!

The natural corridor for nature will be barred by the fencing proposed = no pipeline. Any advancements you propose will be negated and more by these proposals. You should not shy away from voicing this because it goes against Gov.

The Canal & River Trust has had a lot of input to the LNRS and was involved on the steering group. We welcome the Strategy as a means to support identification and prioritisation of actions, and collaboration. In view of our network providing significant connectivity, we welcome the Overarching Priorities, and identification of some sites as ACB's, where they're not APIB's. Some Priorities and Measures for watercourses, such as C/M11 (managing canals such that they retain water if in danger of drying out); and C/M5 (remove or modify obstructions to fish passage) will require collaboration.
